Golf writers often refer to "medai play" (not found in the Rule Book), instead of "stroke play" (used throughout the Rule Book); talk about a two-stroke penalty for out of bounds; use the term "dormie" to refer to the score of the player who is down instead of the player who is up; and overlook the difference in Rules between an attended flagstick and an unattended flagstick. A little research would turn up many other discrepancies.

Maybe some urging on your part might get the golf writers better in line with the Rules.
