

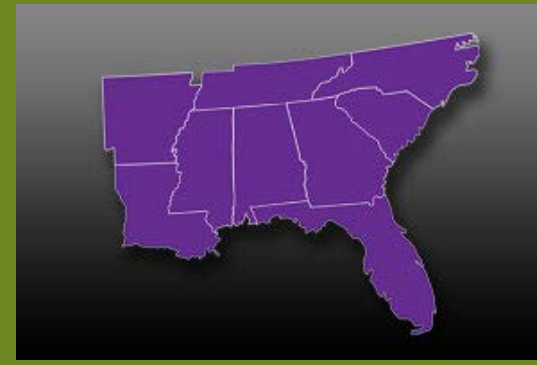
REGIONAL UPDATES
